MINIMUM SPECIMEN REQUIREMENTS

Extracted DNA

- 50 µl of extracted DNA
- Concentration ≥ 10 ng/µl

FFPE sections

- Maximum of 3 FFPE sections
- $\geq 10\%$ neoplastic cells

Whole blood & bone marrow

- 10 µl of whole blood or bone marrow



15 MUTATIONS DETECTED IN ONE KIT

The Idylla™ IDH1-2 Mutation Assay Kit qualitatively detects mutations in the *IDH1* and *IDH2* genes. The Kit detects 5 mutations in codon 132 of the *IDH1* gene and 10 mutations in codons 140 and 172 in the *IDH2* gene.

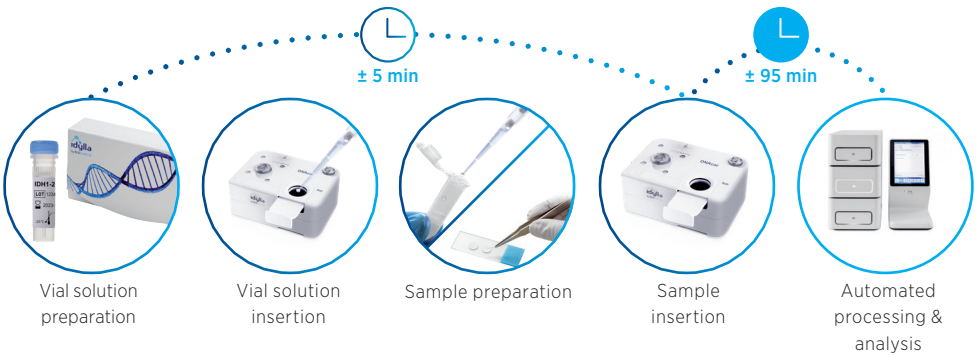
